Mystic Verdant is a high concentrate green colored pigment which will improve visual color and aid in marking spray applications. The unique color combination in Mystic Verdant is designed to mimic actively growing grass.

DIRECTIONS FOR USE READ ENTIRE LABEL BEFORE USING SHAKE WELL

When mixing Mystic Verdant with another product, always conduct a jar test and test on a small area to ensure compatibility. Fill the spray tank with water and start agitation, add product then fill remainder of the tank with desired solutions.

TURF APPLICATION

Apply at a rate of 8-20 fl oz per acre in 40-120 gal of water per acre. Higher heights of cut require higher rates and possibly application in two directions to achieve uniform coloration. Additionally, semi-dormant and dormant turf require higher rates and possibly application in two directions to achieve uniform coloration. Make subsequent applications as needed to achieve desired color. Thoroughly clean sprayer after each use.
